



5. Objectives:

To assist, promote, establish, run, takeover and/or manage orphanages, rescue and/or halfway homes for destitute, aged and the infirm and/or senior citizens without discrimination as to caste, creed, race, religion status or standing.

To give out grants, scholarships, stipends, rewards, awards, certificates, financial and/or other help in cash or in kind in furtherance of the objects of the Trust.

To create endowments institute grants, establish funds and/or foundations such other devices to realize the objects of the Trust.

To open branches, associate institutions, units and/or trusts wherever it is deemed necessary and expedient.

To affiliate, merge, associate, co-operate, takeover, acquire, manage or run other Trusts, institutions, associations, organizations and setups having similar objectives for the general welfare of the public.

To Volunteer and render help; assistance in whatever manage to the victims of natural calamities such as draughts, floods, fires and the like.

To seek from inland or foreign sources grants, donations, and/or assistance in any other form with due permission from the Government, quasi Government and such other authorities wherever necessary.

To assist in the entrepreneurship of the trainees of various institutions of the trust for them to be self sustaining and help them in the marketing of the products and produce and incidentally generate funds to the realization of the objects of the Trust.



**6. Board of Trustees:**

The Trust shall be administered by a board of trustees and first board of Trustees shall be as follows and shall hold the office through out their life time unless contravening the clause 8.3 (I, II, III, IV, V) of this deed,

1. Sri HARISH C shall be the Founder and Chairman Trustee.
2. Sri.V.T.SHANKAR NARYANA REDDY shall be the Trustee and TREASURER.
3. Smt SANDHYA S shall be the trustee and SECRETARY.

The Board of Trustees if they so desire may co-opt additional trustees subject however to a maximum number of eleven trustees.

A Trustee on Trustees shall cease to hold the office of the Trust on his/her

1. Resignation subject to the acceptance by the board of Trustees
2. Death
3. Incapacity such as insolvency, lunacy and criminal offense or moral torpid
4. Permanently leaving the Country.
5. Conduct and/or action proved to be against the objects and interest of the Trust whereupon the boards of trustees have expelled such trustee after giving the party or party's reasonable opportunity of being heard.

Any vacancy due to afore said circumstances shall be filled up on by co-option by a majority decision of the board of trustees, such co-opt trustees shall hold office till the un-expired term of office of the Trustee or Trustees who has or have vacated the office by, however the approval of the Trustee is not a pre-requisite for the appointment of Trustee in case of the following:

- a. The person nominated after the lifetime of the Trust Donor Trustee by a specific statement in writing addressed to the Trust and in the absence of such nomination any person elected and nominated by the board of Trustees.
- b. In case of the death of the any Trustee the legal representative/heir or any person nominated by the deceased trustee will be admitted by the Trust to carry out the objects of the Trust.
- c. There be no such person, or no such person able and willing to act, the author of the trust if he be alive and competent to contract, or the surviving or continuing trustees or trustee for the time being, or legal

Every such appointment shall be by writing under the hand of the person making it.

On an appointment of a new trustee the number of trustees may be increased.

The provision of this section relatively to a trustee who is dead include the case of a person nominated trustee in a will but dying before the testator and those relative to a continuing trustee include retiring trustee if willing to act in the execution of the power.

## 7. Rights and Duties of Office bearers:

The board of Trustees shall for the present having elected the following a office bearers of the trust from among themselves shall have the rights, duties, and powers as the office bearers.

### 7.1 Chairman and Founder trustee:

The Chairman shall be responsible for affixing the seal of approval for any or all the matter pertaining to the Trust objects and functions. In the absence of the Chairman the secretary shall preside over the meeting. In addition to the above he will be responsible for overall supervision of the affairs of the Trust matter

### 7.2 Trustee:

The Trustee shall do all the acts and deeds, which may be necessary and expedient to achieve the objects of the Trust but in consultation with the Chairman. However, the decisions taken by the Secretary are to be ratified in the immediate next meeting of the Board of Trustees. The secretary shall maintain and keep all the records of the trust at the registered office of the trust. He shall call the meeting of the Board of trustees in consultation with the chairman on his failure to call the meeting within three days of taxation with the Chairman; the Chairman shall be entitled to call the meeting with a notice under his signature. He shall record the minutes of the entire meeting and will implement resolutions thereof. He shall prepare the annual report and shall do all other acts as may be assigned to him by the Chairman of the Trust. He shall always keep informed the chairman of the activities of the Trust.

### 7.3 Treasurer:

The trustee also being the Treasurer shall be responsible for maintaining regular and proper accounts of all receipts, payments and liabilities of the trust. He shall get accounts audited within four months of the close of the financial year and place them before the board of trustees. He shall prepare budgets estimates for the ensuring year and do the Board of Trustees approve them. He shall do all other acts as may be assigned to him by the Chairman.

### 8 Powers/ Functions of the Board of Trustees:

With a view to carrying out the objects of the Trust here in above mentioned and to manage and administer the trust funds and without prejudice to the generally of any powers by law conferred or implied or vested in the Board of Trustees. The Board of Trustees shall have the following powers:

- 8.1 To apply and use the funds for all or any of the objects of the Trust and/or to accumulate the surplus unapplied portion of income and invest the same.
- 8.2 To receive any money or other assets in any shape or form as gift donation and to hold the same as capital fund and/or apply for furthering the objects.
- 8.3 To invest funds from time to time in such a manner as may be permitted under the provisions of the Income Tax Act and to dispose of alter and/or vary the investments from time to time to realize the objects of the trust.
- 8.4 To compromise, compound. Abandon, submit to arbitration or otherwise institute or defend any action, suits, proceeding claims or things what so ever arising out of the administration of the agreements, instruments and composition or arrangements, releases and other things as may seem expedient, without being liable or responsible for any loss occasioned by any set or things so done by them in good faith.
- 8.5 To acquire or to dispose off brought mortgage, hire, lease or otherwise movable or immovable, tangible or intangible properties and rights and benefits and to manage the same.
- 8.6 To receive, collect or realize or cause collection or realization of all income that accrue or become due on all or any investments and grants receipts and discharges.
- 8.7 To represent the Trust or cause to be represented by anybody duly authorized by the Board of Trustees in all courts (Original and Appellate) or before judicial or quasi-judicial authorities and other authorities, departments of Government, semi-government or local authority.



- 8.8 To sign and verify all pleading, memoranda of appeal, petitions and applications of all kinds and to engage lawyers and other professionals and take all such other necessary steps.
- 8.9 To borrow or raise any money that may be required by the trust upon such terms as may be deemed fit and to secure money so borrowed by mortgage/charge of all or any part of the assets belonging to the Trust.
- 8.10 To open and maintain accounts with scheduled banks and authorize operation of such accounts by any of the members of the Board of the trustees jointly or severally and to draw, accept; endorse discount and or negotiable and quasi-negotiable instruments on behalf of the Trust.
- 8.11 To pay out of the Trust funds, salaries, wages, rent, buildings, maintenance, repairs, and other expenses relating to the Trust, its administration, management of its activities or its other affairs.
- 8.12 To appoint and/or dismiss staff executives, officials, caretakers, attendants and other employees on such terms as the Board may think fit.
- 8.13 To appoint committees or subcommittees from among the members of the Board and/or along with the others and assign duties and to frame such rules of business as the board shall make fit and alter or vary the terms of the business, which shall not be inconsistent with the terms of these presents. The board shall entitle to frame, constitute and regulate the procedures of such committee or subcommittee.
- 8.14 To under take and carry on any other work which may seem to the Board capable of being conveniently carried on in connection with or calculated, directly or indirectly to help the promoters of the Trust.
- 8.15 To decide all questions arising in the administration of Trust and including all questions relating to the interpretation of these presents, the administration of any institution maintained by the Trust or concerning any matter relating to connected with or arising out of these presents or the operation thereof. The decision of the Board in all or any of the matters aforesaid shall be final.
- 8.16 To do all other acts and deeds and things which may be necessary and expedient in realizing the objects and aspirations of the Trust and to that endeavor seek help, assistance, support of both individuals and/or persons any kind of right concerning affairs of the trust.



- 8.17 The trustee may at their discretion by a majority decision constitute an executive committee for effective implementation of the objects of the Trust and for laying the organizational infrastructure of the Trust for execution of the Trust and appoint such number of officers and employees as they deem necessary on such remuneration in the rules and regulations that the Board of Trustees may frame as they think fit.

- 8.18 The Board may invite any eminent person in public life who has been or is desirous of serving the causes of the trust to head the executive committee for the trust that may be constituted and may frame rules and regulations for the conduct of business of the executive committee.

- 8.19 A GENERAL BODY of the Trust shall be constituted, the members of which shall be all the trustees and the head of the executive committee (if any) duly constituted by the board of trustees.

- 8.20 The GENERAL BODY shall meet at least twice in a year, which will be devoted to the discussion, review and adoption of the activities of the Trust. The Chairperson or in his absence the vice-Chairperson or the managing Trustee if any or the secretary in that order shall preside over the GENERAL BODY.

The General body may discuss any matter pertaining to the activities of the Trust and pass suitable resolution for conducting the activities of the Trust.

#### 9 Accounts and Audit:

The Treasurer shall keep or cause to be kept proper books of accounts and records or cause to be recorded all the receipts and payments and also maintain or cause to be maintained documents relating to these transactions. All the accounts of the trust shall be maintained regularly every year and the accounts shall be closed by 31<sup>st</sup> March and shall be duly audited by chartered accountant and such other competent authority as may be prescribed by the statute.

#### 10 Bank accounts and Instruments:

The treasurer under the authority of board of trustees may open bank A/c in the name of the trust and such account or accounts shall be operated jointly with the secretary / Chairman. The treasurer is entitled to sign, and authorize all negotiable instruments, Cheques, other types of instrument drawn in favor of the trust of any body as may be required for the purpose of the trust as afore said.

# 11 UTILISATION CLAUSE

Hereby declared for the removal of doubts the benefits of trust shall be open to all without any distinction of caste, creed and religion.

# 14 INVESTMENT CLAUSE

The funds of the Trust shall be invested in the mode specified under the provision of Section 13 (1) (d) r.w.s. 11 (5) of the Income tax act, 1961 as amended from time to time.

# 15 Meetings:


The trustee shall meet as often as the circumstances require transacting the business of the Trust. There shall be at least four meetings of the Trustee in the year. The secretary shall convene the meetings of the trustee and prepare the Agenda. The secretary shall be responsible to record or cause to be recorded the minutes of the meeting. He shall report to the Board of Trustees of the action taken by him implementing the directions of the trustees.

12.1. The decisions of the Board of Trustees shall be taken on the basis of majority Votes. In case of equality of votes, the chairperson of the meeting shall exercise the casting vote.

12.2. The Quorum for a meeting shall be two. When the Board in constituted in full strength with eleven Trustees, the quorum shall be five. If there is no quorum the meeting may adjourn and the requirement of quorum shall not apply for such adjourned meeting.

- 13.6 The Trustee shall have the power to alter / amend/ delete / substitute the provisions of deed of the Trust.
- 13.7 It is hereby declared that the secretary and any one Trustee authorized by the Board of Trustees shall have power to execute any documents require to be registered under the law and it is further declared that such documents shall be deemed to have been properly executed by the Trust.

14. Dissolution Clause:

In the event of dissolution or winding of trust the asset remaining as on the dissolution shall under no circumstances distributed among the trustees or members of the managing committee, Govt. body but the same shall be transferred to another charitable trust whose objects are similar to those of this trust and which enjoys recognition under section 80 G of the Income tax act, 1961 as amended from time to time.
