1. The relevant rules applicable in this regard and the instruction issued by Government in Department of School Education and Literacy in this regard shall be followed by the management.
2. This No Objection Certificate shall not be construed as a letter of permission, recognition or registration to start a school. The School shall not be started until and unless the CISCE/ CBSE, as the case may be, accords affiliation. Starting of pre-primary, primary or secondary classes merely on the basis of this NOC without obtaining prior formal affiliation to CISCE/ CBSE is not permissible. However, the institution can start pre-primary, primary, secondary classes after registering and obtaining recognition under the Karnataka Education Act and the rules made there under till it obtains affiliation to CBSE, If any institution starts pre-primary, primary or secondary classes without prior registration and recognition under the State Act and the rules and also without prior affiliation to the CISCE/ CBSE, it would be in violation of the provisions of the Karnataka Education Act and rules and will be liable for penal action under the said Act/rules.

3. The fees collected by the Educational Institutions following CISCE/ CBSE for each term from the students shall be subject to rules made by the State Government from time to time in this regard. No capitation fee or voluntary donations for gaining admission in the school or for any other purpose should be charged/ collected in the name of the school.
4. In case a student leaves the school for such compulsion as transfer of parents or for health reason or in case of death of the student before completion of the session, pro-rata return of quarterly/term/annual fees should be made.
5. The school should consult parents through parent's representatives before revising
6. The fee should not be revised during the mid-session. After obtaining affiliation to CISCE/ CBSE, the management shall teach Kannada language compulsorily as a
7. The management shall provide infrastructure as per the norms prescribed.
8. The Management/School should appoint teachers with TET qualifications and this must be reflected in their resolutions.
9. The management shall not collect any donation from the students or their parents/guardians and collect only the fees prescribed by Government from time to time as per the provisions of the Karnataka Educational Institutions (Abolition of Capitation Fee) Act, 1984 or as prescribed by the CISCE/CBSE, as the case may be.
10. Children of those belonging to the All India Services/Central Services liable to inter-state transfer, migrants from out of State who are temporarily put up in the State of Karnataka/employees of all India level business/commercial and industrial establishments and Anglo-Indians shall get preference in admissions.
11. The School/college student enrollment and attendance as well as supervision of building facilities and administrative matters of the Department of Public Instruction, in the context of the issue under the State Government's duty to maintain and be bound by the orders and circulars.
12. The NO OBJECTION CERTIFICATE along with the conditions subject to which the same has been issued should be exhibited in a conspicuous place in the office of the school next to the notice board for the benefit of general public.
13. For starting the pre-primary school (Nursery/LKG/UKG etc.,) the management shall obtain prior permission by registering the same in accordance with the Karnataka Educational Institutions (Classification and Registration) Rules, 1997.

14. The management shall extend all co-operation to the officials of the State Education Department whenever they visit their schools for inspection even after getting affiliation to CISCE/ CBSE.
15. In case any of the conditions mentioned above is violated, the officers concerned in the Department of Public Instruction shall be free to take action as per law and Government of Karnataka shall be free to withdraw the NOC given by it.
16. Admission to pre-primary stage should be done in the month of April every year.
17. The school being governed by Government of Karnataka's regulations for safety and security of students.
18. The school should admit the students under RTE Act during 2022-23 and in future
19. Any other conditions that may be imposed in future.

III. The school shall not claim any grant-in-aid ever.

IV. Institution get affiliated with CISCE/CBSE Board within the period two years from the date Of issue of No Objection Certificate. If fails, the No Objection Certificate should be renewed further.

NOTIFICATION

Whereas the draft of the following Rules, further to amend the Karnataka Education Institutions (Issue of No Objection Certificate and Control) Rules, 2022 which the Government of Karnataka proposes to make in exercise of the powers conferred by sub-section (1) of section 145 of the Karnataka Education Act, 1983 (Karnataka Act 01 of 1995), in Notification No. ED 44 PGC 2023, dated: 07.02.2023 in part IV-A No.51 of the Karnataka Gazette Extraordinary dated: 07.02.2023 inviting objections and suggestions from all persons likely to be effected thereby within fifteen days from the date of its publication of the draft in the Official Gazette.

Whereas the said Gazette was made available to public on 07.02.2023.

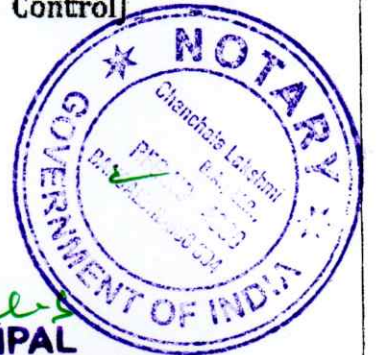
And whereas the objections and suggestions received in this behalf have been considered by the State Government.

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 145 of the Karnataka Education Act, 1983 (Karnataka Act 01 of 1995), the Government of Karnataka hereby make the following rules, namely:-

RULES

1. **Title and Commencement.**- (1) These rules may be called the Karnataka Education Institutions (Issue of No Objection Certificate and Control) (Amendment) Rules, 2023.

(2) They shall come into force from the date of their final publication in the official Gazette.

2. Amendment of rule 4. In the Karnataka Education Institutions (Issue of No Objection Certificate and Control) Rules, 2022(hereinafter referred as said rules), in rule 4,-

(i) for sub-rule (3), the following shall be substituted, namely:-

(3) The Deputy Director is designated to receive all such applications and issue the No Objection Certificate on merits. In this regard, applications shall be verified by the DDPI to confirm its adherence to these rules, the Act and other applicable rules made. thereunder. A site visit may be made by the concerned Taluk Block Education Officer to ensure the merits before granting the NOC.";

(ii) sub-rules (4) and (5), shall be omitted; and

(iii) for sub-rule (6), the following shall be substituted, namely:-

"(6) The Commissioner for Public Instruction shall be the Appellate Authority in the matters."

3. Amendment of rule 5.- In rule 5 of the said rules, for the word "Government", the words "Deputy Director for Public Instructions, shall be substituted.

4. Amendment of rule 6.- In rule 6 of the said rules,-

(i) in the heading for the words "Role of State Government", the words "Withdrawal of NOC", shall be substituted;

(ii) in sub-rule (4), for the words "DDPI/BEO", the words "Deputy Director for Public Instructions", shall be substituted;

(iii) in sub-rule (5), for the words "State Government", the words "Deputy Director for Public Instructions", shall be substituted; and

(iv) sub-rule (6), shall be omitted.

5. Amendment of rule 7.- In rule 7 of the said rules, for sub-rule (1), the following shall be substituted, namely:-

"(1) No modifications shall be made in the NOC. However, if the Institution seeks change in the name, suitable orders may be passed by the Deputy Director for Public Instruction as per these rules. Such applications shall be submitted to the Deputy Director for Public Instruction."

6. Amendment of rule 8.- In rule 8 of the said rules,-

(i) for the words "the Government may pass suitable orders based on the recommendations of the Commissioner by considering the following documents," the words "the DDPI may pass suitable orders based on considering the following documents," shall be substituted; and

(ii) for item (b) and entries relating thereto, the following shall be substituted, namely:-

"(b) A physical inspection report of the school or institution by the concerned Taluk Block Education Officer."

7. Amendment of rule 9.- In rule 9, in sub-rule (2) of the said rules, for the word "de-recognition", the words "derecognized and Further, such institutions shall be debarred from seeking NOC for a period of two years" shall be substituted.
